Course Objectives:

This course will focus on a study of the social origins of criminal law, the administration of justice, causes and patterns of criminal behavior, and the prevention and control of crime, including individual rehabilitation and institutional change, and the politics of legal, police and correctional reform. We will study crime and its effects on society from the viewpoint of the offenders, victims, defense attorneys, prosecutors, police, judges, and others involved in the administration of justice.

Course Requirements:

There will be no term paper for this class. Grades are determined by one midterm, one final exam, and attendance and participation. Both the midterm and final will consist of three parts:

- a short multiple-choice test taken in class and closed book.
- a short in-class essay taken in class and closed book (bring a blue book.)
- a take home essay response (from a choice of two prompts.) open book.

Each part of the exam will be equally weighted. The take home essay portion of the exams will be open book. The in class multiple-choice and blue book essay portion of the exams will be closed book. MAKE-UP EXAMS WILL NOT BE OFFERED, EXCEPT FOR VERIFIED MEDICAL EMERGENCIES.
